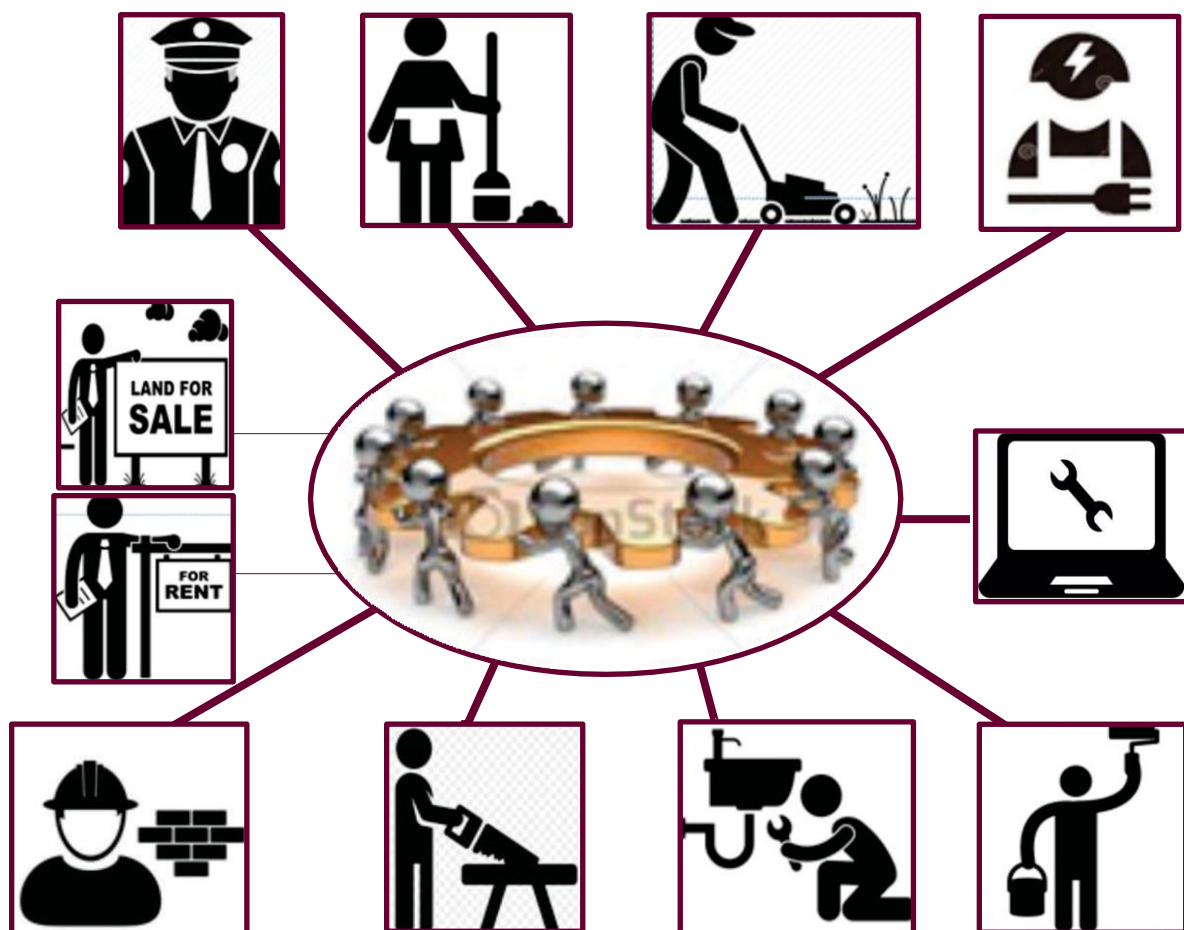
INTRODUCTION
